The Challenge for The Client

Scoping, assessment, remediation, and validation comprise the certification process.

To re-certify two years later, organizations must complete an interim assessment and show remediation or significant progress in closing security gaps (CAPS). The interim and recertification criteria are repeated annually to ensure firms remain compliant with the **HITRUST CSF.**







Accorian began preparing the client for **HITRUST** by giving the project team an overview of the framework. Everyone involved in the process must understand their role and how **HITRUST** will affect them. Since management buy-in is vital, educating management and leadership on the upcoming changes is also essential.

Preparations included drafting a realistic and achievable implementation schedule as well. We had a predetermined set of steps for the audit's preparation. It had three phases.

The organization's preparedness was assessed after defining the scope of work. We also used **HITRUST MYCSF** to visualize the sheer number of controls under consideration. Then, we assessed the firm's **HITRUST** domains and identified any potential pitfalls. A roadmap was designed to address these issues.

During the second stage of audit preparation, we worked closely with the client to execute the plan and develop case-specific rules and procedures. A full program management and on-demand security assessments were also available.

In the third phase of preparation, we validated our client's evidence on MYCSF. We worked as a team with our client to identify gaps and develop solutions. Finally, we sent the reports to **HITRUST for certification**.
